

LTCOP History

- 1972 Pilot Programs in nursing homes
- 1978 National Program created as part of Older Americans' Act (PL 89-73)
- 1981 Expanded to include "board and care" facilities
- 1987 Nursing Home Reform Law establishes Residents' Bill of Right
- 2006 Expanded to include assisted living facilities

LTCOP Services

- Resident-Centered Advocacy
- Facility Monitoring Visits
- Complaint Investigation and Resolution, including Abuse Investigation (CA mandate only)
- Witness Advanced Health Care Directives (CA only)

LTCOP Services

- Information/Referral/Consultation including placement information
- Community Education
- Systems Advocacy: State and Federal

Ombudsman Authority: Federal

- Private, unimpeded and immediate access to LTC facilities and residents.
- Access to residents' files, records with permission or if LTCO believes a resident representative is not acting in the resident's best interest.
- Access to facility records, policies and documents accessible to residents and the public.

42 USC Section 3058(g)

Ombudsman Authority: State

- Unescorted, unhindered movement within LTC facilities at any time deemed necessary and reasonable by the State Ombudsman.
- Civil penalty \$2,500 for willful interference
- Willful interference is reported to local law enforcement as an act of isolation (elder abuse)

California Welfare & Institutions Code Sections 9722, et seq.

Common Issues in Long Term Care

- Discharge/Transfer
- Failure to respond for requests for assistance
- Staff attitude
- Medication Management
- Admission agreements
 - Financial responsibility
 - Services
 - Arbitration

What Happened in Long Term Care During Covid?

- Some Resident Rights Suspended
- Visitor Restrictions -> Isolation
- Infection Control Procedures
- Staff Training Requirements Reduced
- Staffing Shortages
- California did not give LTC facilities immunity

CA-LTCOP Legislative Priorities

- SB 650 Annual consolidated financial reports from SNF owners/operators/managers/lessees showing related party transactions of 5% or more.
- AB 749 SNF Medical Directors must be certified in post-acute and long term care medicine.
- SB 48 Provide HCP training to promote early diagnosis for Alz and other dementias.
- AB 665 RCFE's that provide internet access must provide videoconference technology.
